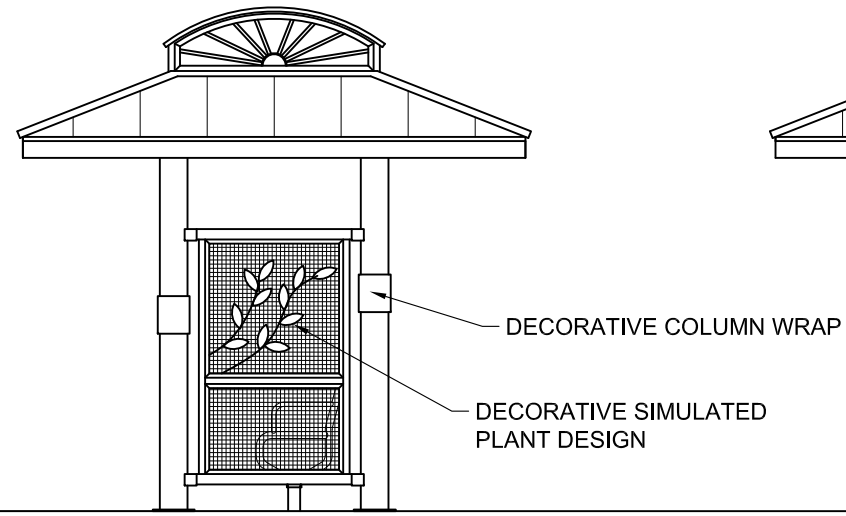
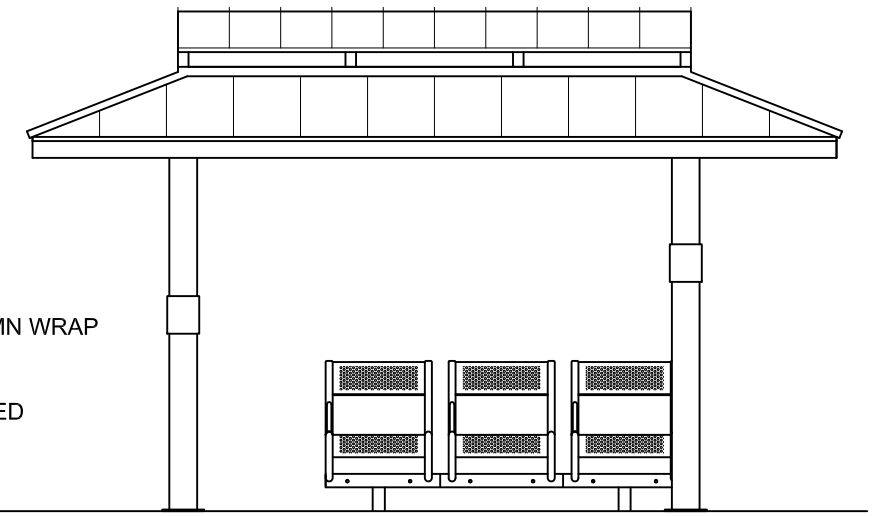


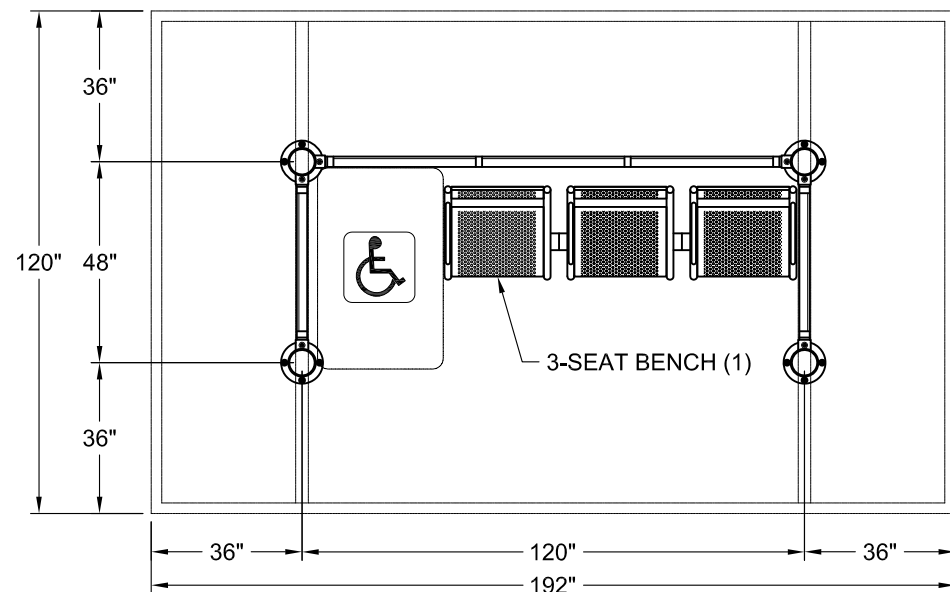
TYPE 2 STANDARD FRONT ELEVATION



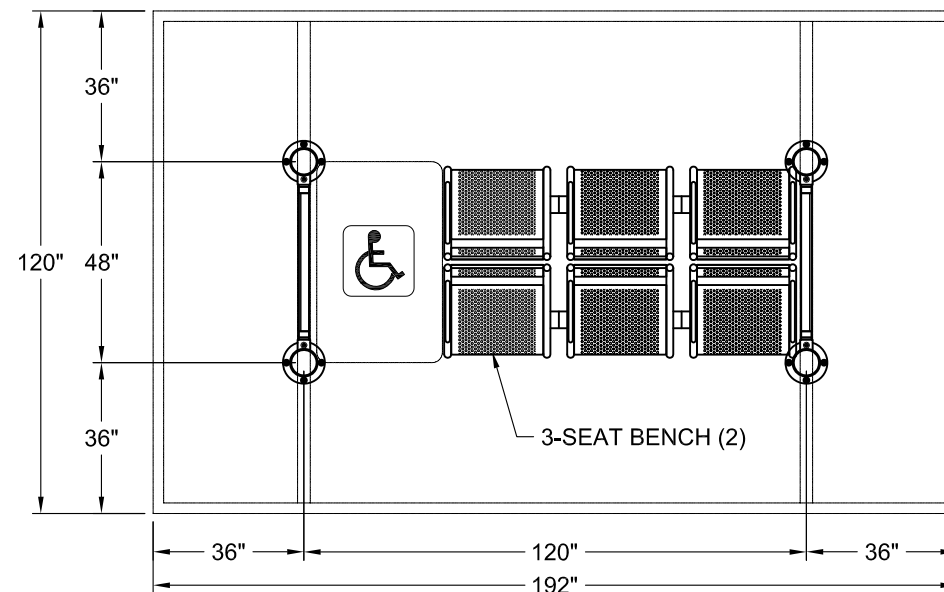
TYPE 2 STANDARD SIDE ELEVATION

CUSTOM ARTWORK / DECORATIONS:

- *SIDE SCREENS TO HAVE FAUX ALUMINUM DECORATIONS SIMULATING RED GINGER STALK/LEAVES, RIVETED TO SCREENS AND FINISHED TO SIMULATE NATURAL DESIGN, DONE BY LOCAL MAUI ARTIST.
- *EACH COLUMN TO HAVE A DECORATIVE "RAT GUARD" WRAP, WITH TROPICAL DESIGN, FINISHED TO MATCH GINGER PLANTS ON SCREENS, RIVETED TO COLUMN. ONE WRAP PER SHELTER TO HAVE IDENTIFYING LOGO AND INFORMATION. BY LOCAL MAUI ARTIST.
- *SCREENS AND COLUMNS TO HAVE 2-PART EPOXY PRIMER AND 2-PART EPOXY URETHANE TOP COAT, TO MATCH EMERALD GREEN ROOFING, BY LOCAL MAUI ARTIST.
